V. SUMMARY AND ANALYSIS OF COMMENTS RECEIVED

A. Summary and Analysis of Public Hearing Comments

On May 19, 2005 an Eminent Domain Procedure Law Public Hearing was held at Public School 195/196/197's auditorium located at 1250 Ward Avenue, Bronx. The purpose of the meeting was to obtain input from the property owners affected by the Bronx River Greenway project as well as from the general public.

Approximately 50 people attended the hearing. In addition to recording oral statements, the New York State Department of Transportation (NYSDOT) provided all attendees with comment cards, which were distributed and collected. At the hearing it was stated that a NYSDOT Real Estate representative will be available during the hearing, after the hearing and throughout the design process to answer any questions they have regarding their property. A stenographer was present to officially record the oral presentation and public statements. Copies of the stenographer's transcript can be found in the Appendix.

The presentation to the public included the use of digital orthoimages of the project area in which there are right-of-way easements or acquisitions. There were also graphic visualizations of what the proposed project will look like after it is completed. The oral presentation included a speech from the Administrative Law Judge, a Powerpoint slide presentation from the NYSDOT design team and a speech from the NYSDOT Real Estate representative. The presentation outline included:

The most common concerns noted were security of the multi-use path and its surroundings as well as its hours of operation. Below is a paraphrased summary of specific comments received during the hearing followed by the Department's response.

Specific Comments and Concerns:

1. *Comment:* The retaining wall should be higher.

Response: The height of the retaining wall will be modified during Final

Design to address the adjacent residences concerns over safety and

aesthetics.

2. *Comment:* The multi-use path needs proper lighting.

Response: The Bikeway will contain lighting that has been designed to meet

the standards and requirements of the NYC Department of Parks

and Recreation.

3. *Comment:* There needs to be security cameras.

Response: Once completed the Greenway will be maintained and operated by

the Parks Department. Security measures and the use of cameras will be discussed with the Parks Department during Final Design.

4. *Comment:* The path should not be open 24 hours a day. Implement a curfew.

Response: The Parks Department will operate the park and will establish the

hours of operation. Discussions with the Parks Department on the hours of operation and the appropriate security measures will be

held during Final Design.

5. *Comment:* There needs to be 24 hour a day security.

Response: See responses 3 and 4 above.

6. *Comment:* There needs to be police patrol.

Response: Please refer to responses 3 and 4 above.

7. *Comment:* What will happen to the vegetation/trees in the affected easements?

Response: Measures will be taken to preserve existing vegetation wherever

possible. In the easement areas where vegetation must be removed for construction purposes, new vegetation will be established at the

completion of construction.

8. *Comment:* The security gate needs to have a certain height.

Response: The height of the fencing and gates will be modified during Final

Design to address the adjacent residences concerns over safety.

9. Comment: Will there be another number besides 911 posted to report and

encourage people to report vandalism, garbage dumping, fights,

etc.?

Response: Evidence of vandalism or dumping can be reported to either the

Police or the Parks Department. The Police should be notified of illegal activities through normal communication procedures. No

special number will be established to report these incidents.

10. Comment: How fast will help come in case of an accident or emergency in the

Greenway?

Response: The path and bridges have been designed to accommodate

emergency vehicles so that response times for incidents on the

Greenway can be similar to those in the adjacent neighborhood.

11. *Comment:* There needs to be community access to the river.

Response: The Greenway will contain overlooks and walking paths that

provide public access to the banks of the Bronx River.

12. *Comment:* There needs to be more greenway in the South Bronx.

Response: The Bronx River Greenway will add over 14 acres of green space

and provide connections to the other green space areas in the South

Bronx.

13. Comment: There should be a continuation of engaging the local community

residents, business owners and other stakeholders at all stages of

the greenway development process.

Response: NYSDOT plans to hold other meetings with the public at various

stages of Final Design. The purpose of these meetings will be to discuss the project progress and adjust the design to incorporate the

community's concerns.

14. Comment: The Bronx River Greenway promises to be a magnificent

contribution by the NYSDOT to the community.

Response: No response required.

15. Comment: By maintaining a transparent process that works with community

and is attentive to potential public safety or environmental concerns, the NYSDOT will continue to have community support. The NYSDOT should be applauded for holding this meeting and for thus far being open to working with the Bronx River Alliance and other community stakeholders in designing and planning the

Greenway.

Response: As discussed in the response to comment 13, NYSDOT plans to

hold meetings throughout the Final Design process to discuss

issues with the community.

16. Comment: The Youth Ministries for Peace and Justice would like to thank all

community members, organizations (especially the Bronx River Alliance and its members), and the NYSDOT for your roll in getting the Bronx River Greenway as far as it is today. Thanks to these efforts, our South Bronx community has the promise of a

more beautiful and healthy future.

Response: No response required.

17. Comment: The more green space and less amount of cars, the better the

chance that Asthma will decrease in the Bronx community.

Response: Please refer to the response to comment 12.

18. Comment: The South Bronx community needs more open spaces that are safe

for the children to play.

Response: Please refer to the response to comment 12.

19. Comment: The park land of the Greenway will provide a place for children to

play besides the streets.

Response: No response required.

20. Comment: The Greenway will promote a cleaner Bronx River that residents

will no longer be embarrassed about.

Response: No response required.

B. Analysis of Comments Received on the DR/EA

Written comments were received on the DR/EA from the United States Environmental Protection Agency (EPA). In a June 10, 2005 letter to NYSDOT the EPA commented on the presence of endangered species or habitats in the project area and requested back up on the field studies completed for the project. The EPA is particularly concerned with the Department's program of invasive plant removal, which is being progressed independent of the Bronx River Greenway project. The EPA letter also suggests the use of alternative/green building materials for the project. A copy of the EPA letter along with an itemized response to their comments can be found on the following pages.

The Soundview Park parcel transaction is completed; the parcel within the Concrete Plant may not be 100% complete.

Page II-3, last bullet

Our understanding is that the CSO relocation and storage tank concept is not part of DEP's current capital plan.

Page II-5, Fifth paragraph, 3rd line

The sentence should change "my" to "by" NYCDPR or by NYSDOT..."

Page II-12

For Table II-5, can a map or diagram illustrate the greenway path and its relation to the identified bridge structures?

Page II-16

The Melrose Commons Urban Renewal Plan is not stalled. The plan was approved by the Department of City Planning in 1994. Significant housing development has already taken place in the project area as a result of the designation of the urban renewal area. As of last August, new construction residential projects which are either completed, in construction, or have had funding approved and developers designated, have a combined total of more than 1500 dwelling units.

Page II-17, Community District 9

An existing building on the LORAL site was rehabilitated as a public school last year.

III. Alternatives

Page III-8

Parks will be constructing a boathouse in Starlight Park upon NYSDOT's completion of park reconstruction, which follows Con Edison's remediation.

Page III-13 g. Maintenance Responsibility Please see page I-2 comment above.

III. Social, Economic and Environmental Considerations

Will there be any impacts to the Bronx River Art Center during construction? I am not sure what is involved with the north side of East Tremont when the new crossing is constructed. I think what would be needed, if necessary, is notification to the Bronx River Art Center upon any changes to the adjacent sidewalk and assurances that access would be maintained.

C. List of Permits

New York City Department of Parks and Recreation should be added to the list of agencies for anticipated permits. This will be necessary for construction in Starlight Park and for any tree removals and tree protection.
